Subject to the transitional arrangements set out in clause 4, the Corporation shall consist of: (a) up to eighteen **External members** who appear to the Corporation to have the necessary skills to ensure that the Corporation carries out its functions under article 3 of the Articles of Government; (b) **the Principal** of the institution, unless the Principal chooses not to be a member; (c) at least one and not more than three members who are members of the institution’s **staff** and who have a contract of employment with the institution and who has been nominated and elected as set out in paragraphs (3), (4) or (5) (“staff members”); and (d) **two students** at the institution who have been nominated and elected by their fellow students, or if the Corporation so decides, by a recognised association representing such students (“student members”).
